Clause 6.	To be a partner with limited liability of any limited partnership and to become a shareholder of any other limited company and public limited company.	To be a partner with limited liability of any limited partnership and to become a shareholder of any other limited company and public limited company, or a holder of investment units of mutual fund, including invest or jointly invest in any businesses within and outside the kingdom.
Clause 9.	To engage in the business of trading in vegetables, fruits, bamboo shoots, pepper, cigarettes, pipe tobacco smoking mixture, beverages, drinking water, mineral water, fruit juices, liquor, beer, fresh foods, dried foods, ready-made foods, canned seafood, canned food, seasonings, sauces, sugar, vegetable oil, animal feed, and other consumer products.	To engage in the business of trading in vegetables, fruits, beverages, fresh foods, dried foods, frozen foods, ready-made foods, canned and bottled foods, seasonings, equipment and ingredient for cooking foods, and other consumer products.

To engage in the business of trading fuel, coal, other products that generate energy, and fuel service station	To engage in the business of trading and providing services in all kinds of energy, including all types of alternative energy, all types of petrochemicals, petrochemical refining products, all kinds of natural gas, all kinds of fuel, gasoline, fuel oil, all kinds of oil, coal, other products that generate energy, all kinds of chemicals and chemical products, including to bid, purchase, sale, exchange, lease, hire purchase, sublease, be agent, broker, dealer, commission agent, advise and provide the consults on, research and develop, prepare the application for, accept, and buy a concession, rights or licenses for operating businesses, make and supply tools, utensil, machines, equipment and materials, establish, build and construct factories, refineries and power plants, do any acts relating to all kinds and types of energy and alternative energy, including operate gas and fuel service station and to render repair, maintenance, examination, pressurized cleaning, lubrication and rust prevention for all kinds of vehicles as well as to install, test and repair all types of safety prevention devices.
Clause 15.	To engage in the business of trading medicine, curative medication, pharmacy, chemical products, medical device, scientific devices and instruments, fertilizers, insecticides, all kinds of plant and animal nutrients.	To engage in the business of trading curative and preventative medication for humans and animals, pharmacy, medical supplies, medical and pharmaceutical instruments, scientific devices and instruments, fertilizers, insecticides, plant and animal nutrients, plastic pellets, plastic or other similar items whether in the form of raw materials or finished products.
Clause 22.	To bid for sale of goods to persons, groups, juristic entities, state agencies and organizations pursuant to the Company's objectives within and outside the kingdom.	To bid for sale of goods to and hire of services for persons, groups, juristic entities, state agencies and organizations pursuant to the Company's objectives within and outside the kingdom.

Clause 31.	-	To engage in the business of providing banquet services, cooking service, decoration of places, preparing and serving foods, beverages and other consumer products, food delivery service, laundry service, cleaning service, procurement of raw materials and equipment used in banquets and decorations, food delivery service, cooking, production and distribution of foods, beverages and other consumer products, laundry and cleaning, including other services related to such matters.
Clause 32.	-	To engage in the business of providing guarantees against debt, liabilities and third party contract performance, including providing guarantees for persons entering or leaving the country in accordance with the immigration, revenue and other laws.
